Supported by the very sympathetic and efficient Jeannette Ndaya Tshibangu, René masterfully directs the destiny of the Foundation on a daily basis with the same warmth and professionalism that he has demonstrated in his role at the service of the archdiocese for the past 24 years, 21 of which as communications officer and soon 3 years as bursar.

Message from the Executive Director

"... it's just the beginning..."

These are the words of the chorus of a song entitled "Et c'est pas fini!" by the artist Emmanuëlle. If we had to summarize in a few words the Novatio Foundation's activity report for its first year, the refrain of this song would reflect what the Foundation's management team and board of directors have experienced.

This is only the beginning for the Board of Directors who met several times over the past year to approve, with the support of BNP Philanthropic Performance, the Foundation's constitutive documents such as the by-laws and the major gift and planned giving program.



This is just the beginning of making the mission and purpose of the Foundation known through a initial informational tour in the pastoral regions of the archdiocese.

It is only a beginning with a first call for projects that invited parishes and community organizations of the Outaouais region to present projects. These projects will be supported by Novatio in 2023 for a total maximum amount of \$120,000 according to the priorities that the Foundation has set for itself.

This is only the beginning of the solicitation of donors, starting with the natural allies of the diocesan Church, the "family", to establish the initial fund of the Foundation whose medium and long-term objective is to build a fund of 3 million.

This is only the beginning of the development of a first annual fundraising campaign to ensure the necessary funds for the calls for projects that will be made on an annual basis.

In short, this is not the end of the story. The Novatio Foundation is confident that it will find its place in the landscape of other foundations in the region that are in fact partners in making the world a better place. Novatio wants to make its contribution to a more caring and united world.

Posthumous Tribute to Mr. Pierre Laflamme (1950-2022)

Founding member of the Foundation and first Honorary Member

"I dream of a Church that makes a difference in this world, of Christian communities that contribute to the development of all women and men in their environment. Novatio allows us to put flesh on this dream."

This dream that I presented at the creation of the Novatio Foundation was indeed shared by a wonderful fellow journeyer, our friend Pierre Laflamme who left us last June.



Pierre was one of the first people I met when I was appointed Archbishop of Gatineau. He was then president of the Diocesan Economic Affairs Council, a position he held until 2021 when he became the first chair of the Novatio Foundation. He had already been suffering from cancer for almost a decade. Though, he never stopped working to get Novatio off the ground. Even the pandemic did not break his motion. On the contrary, the negative effects of the health crisis on our community and our Church justified even more his momentum, the need to give ourselves a tool to think and develop new projects in order to ensure the mission of Jesus in the Outaouais, in the heart of our world.

Because of his long personal experience in the financial field and his commitments in the community and in the Church,

Pierre Laflamme had at heart to equip communities so that their human and financial resources would be destined for the essential mission of organizations, the common good. He often visited the parishes of the Archdiocese of Gatineau to analyze their finances. He was happy to share his experience and convictions with generosity and respect for the many volunteers serving their communities.

On its first Annual General Meeting, the Novatio Foundation wishes to posthumously recognize Pierre Laflamme's involvement and dedication to the launch of the Foundation. The Board of Directors therefore awards him the title of **First Honorary Member** of the Foundation. He would have liked to be with us today to mark this first lap. In fact, only three weeks before he left us, he participated in Novatio's Board of Directors to present the Foundation's first budget estimates. What courage!

History and Context of the Creation of the Novatio Foundation

- At the beginning of the third millennium, the parishes of the Outaouais along with the entire Church in Quebec are facing the consequences of a major social change. This change began in the middle of the 20th century. The resources of our Christian communities are diminishing in every respect. Their growing precariousness erodes their capacity to pursue the mission of Jesus in their communities in an autonomous way. Moreover, society has changed and invites us to find a new language, new methods, and a new zeal to continue the work of the Gospel at home.
- To allow the realization of priority projects in the Outaouais region, the Archbishop of Gatineau, Paul-André Durocher, and a group of volunteers founded Novatio.
- The word Novatio, in Latin, means "renewal".
- From 2017 to 2018, the BNP Philanthropic Performance team conducted a pre-campaign study to assess the degree to which the strategic objectives set for the Foundation were supported by the various sectors of the community and to propose a realistic, challenging, and reasonable financial goal for a major fundraising campaign.
- After the study and the results, the launch of the Foundation was put on hold.
- In the spring of 2021, the Foundation's launch activities began, with the development and finalization of its documents, including by laws, donation policies, etc. During this phase, the Foundation was supported by the expertise of BNP Philanthropic Performance.
- In the winter and spring of 2022, the Foundation began with the solicitation for its major gift campaign. Fundraising activities are ongoing.
- A first call for projects was launched in October 2022 and the first grants to fund projects submitted to the Foundation will be awarded in early 2023.

Mission, Vision, and Values of the Foundation

Mission of Novatio

To ensure the mission of Jesus in the Outaouais, the Archdiocese of Gatineau founds Novatio as a tool to promote innovative services and projects, both pastoral and missionary, in fidelity to the Gospel project and in line with the priorities identified by the various synodal bodies of the Archdiocese of Gatineau. In this way, we will be able to contribute to the blossoming of the kingdom of "justice, peace and joy" (Rom. 14:17) that Jesus came to proclaim and inaugurate in our world.

Strategic objectives

- To value the renewed activities, projects and services for pastoral care and missionary impulse emanating from communities, movements, parishes, and the diocesan team.
- To support the funding of these activities, projects, and services.
- To enrich the Foundation for this funding.
- To develop a culture of philanthropy among all members and stakeholders of our local Church.

Values

The Novatio Foundation, a charitable organization, promotes the following evangelical and ecclesial values in its operations and those of its partners:

PARTNERSHIP

To value the partnership between men and women, laity and clergy, employees and volunteers in its structure, activities, and projects.

SOCIAL SOLIDARITY

Reach out to and support the excluded, the poor or the destitute, the elderly, immigrants and youth through a social ministry that aims, among other things, at fighting poverty, respecting human rights and cooperation.

RESPECT AND EQUITY

To value human dignity and promote social justice through individual and collective empowerment.

To commit to respectful care for creation and safeguarding of the environment.

Structure and Administration of the Foundation (continued)

Executive Committee

The President, Vice-President, Treasurer, and Secretary of the Board of Directors shall constitute the Executive Committee. The latter has the authority and exercises the powers of the Board of Directors between meetings of the Board of Directors for the administration of the affairs of the Foundation. The Executive Committee reports on its activities at each meeting of the Board.

Advisory Committee

The Advisory Committee is composed of Novatio Foundation suppliers and volunteers from the legal, investment and financial communities who have an interest in supporting the Novatio Foundation. It was created to advise the Endowment, Planned Giving and Major Gifts Committee and to help inform the public about planned and major gifts.

Endowment, Planned Giving and Major Gifts Committee

The Endowment, Planned Giving and Major Gifts Committee is composed of volunteers who sit on the Novatio Foundation Board of Directors.

Management

The management is held by an executive director who is assisted by an executive assistant.

Activities

Call for projects

Novatio has invited the 58 parishes of the archdiocese, community organizations and church movements of the Outaouais region to submit projects that are in line with the mission of the Foundation and its areas of intervention. The deadline for submitting a project was November 30, 2022. This is the first call for projects for the Foundation since its creation. For this first year, Novatio wants to support projects for a total of \$120,000 thanks to the donations received.


A total of thirteen (13) applications were submitted to the Foundation. A committee made up of members of the board of directors and volunteers will analyze them and make a decision in January 2023.

Activities (continued)

Information sessions

As part of the campaign for planned and major gifts and so as to make the Novatio Foundation known, four (4) information sessions were offered in the pastoral zones of the Archdiocese of Gatineau. Members of the newly annexed parishes in the Maniwaki and Gracefield sectors also participated in the information sessions.

The four sessions were given over a period of two weeks, from April 30 to May 10, 2022, and about forty people took part in these sessions.

Endowment, Planned and Major Gifts Program

The Novatio Foundation's Endowment, Planned and Major Gifts Program aims to raise \$3M to support the Foundation's four themes of intervention and ensure its mission. The parishes and ecclesial movements of the Archdiocese of Gatineau are all points of anchorage, vitality and influence. In these, we find welcoming, dynamic, and committed communities. It is up to all of us to ensure their perpetuation.

When you choose to make a planned gift to the Novatio Foundation, it is invested in a fund that is capitalized according to a rigorous policy. This investment made possible by you, allows the Foundation to use only the interest. This general fund is the base fund that ensures the sustainability of Novatio and the continuity of its operations. It is used to finance donations related to the Foundation's themes of intervention, as well as to finance current operations, and to deal with unforeseeable and uncontrollable emergencies that would threaten the organization and its activities.

A planned gift is usually decided as a result of financial, tax or estate planning and can take many forms:

- Money, works of art, titles or securities, real estate donation
- Donation by bequest
- Gift of life insurance with a minimum value of \$25,000
- Gift of a charitable annuity or registered plan.

You may also make a major (unplanned) gift to the Foundation's general endowment fund. The minimum amount is \$10,000, given in one lump sum or spread over a period of up to three to five years.
