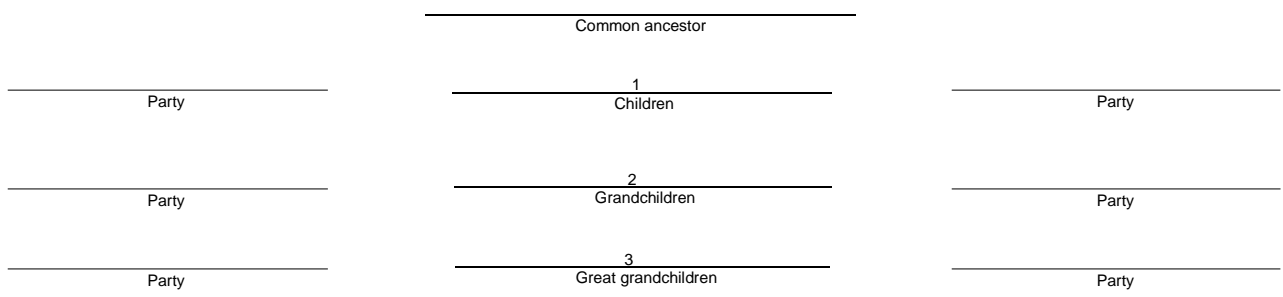

In the case of a mixed marriage or a marriage with dispensation of disparity of worship (can. 1086, 1125) the following declaration by the priest who prepares the couple for marriage is needed (can. 1126; CCCB Decree n. 34):

- The Catholic party has been instructed concerning his/her responsibility to live according to her faith, to give witness to it, to avoid things that might draw him/her away from it and to do everything he/she can to insure that the children will be baptized and raised in the Catholic faith. He/she has sincerely promised to be faithful to these responsibilities. yes
- The non-Catholic party has been made aware of the teachings of the Catholic Church with regards to marriage and is accepting that the marriage he/she wishes to contract is to be one and indissoluble. He/she is aware of the responsibilities of his/her future spouse regarding his/her faith and the Catholic baptism and education of the children. yes
- The parties have been adequately prepared for their upcoming marriage. yes
